DURATION/TERMINATION

Duration

- Plan membership fees cover all services listed in the various Wellness Plans for one year from the date of initial enrollment. All terms and conditions of this agreement will be in effect for the entire length of the enrollment.
- All plans except the Dental Plan will be automatically renewed on an annual basis unless cancelled by either the member or Cats Exclusively 30 days prior to the annual renewal date. No enrollment fee will be charged with renewal.
- If at any time during enrollment in a plan the member moves or the covered patient becomes deceased the member will be responsible for the costs of services already rendered. If the member's payments exceed the value of services already rendered a refund will be issued for that amount and no further quarterly or monthly payments will be due.

Termination

- If the member cancels before any services are rendered any amount paid will be refunded minus the enrollment fee.
- If the member cancels after any services are rendered the member will be responsible for the costs of services already rendered. If the member's payments exceed the value of services already rendered a refund will be issued for that amount and no further quarterly or monthly payments will be due.
- If the member fails to pay any installment within 30 days of the due date Cats Exclusively may immediately terminate the agreement or declare all fees and remaining quarterly or monthly payments due to year end immediately due and payable.

FEES AND PAYMENT

Fees and Payment

- Membership fees are listed under the various Wellness Plans.
- A one-time enrollment fee of \$25 will be billed at the initial enrollment visit.
- The monthly fee will be automatically charged to their credit card.
- Prices are subject to update at renewal
- An overdraft and reprocessing fee of \$30 will be charged for any rejected charges (insufficient funds, expired credit card, or any other reason a payment is unable to be processed). The member is responsible for notifying Cats Exclusively if there is a change to the credit card.
- The Plan is not transferable and applies only to the patient identified at the time of enrollment.
